#### CHECKLIST:

- Step 1 – Did you list your name, last 4 digits of SS# and current address?
- Step 2 – Did you identify the position for which you wish to run for?

- Step 3 – Did you properly identify the district number and your shift? Did you list your name as you wish it to appear on the ballot? Did you sign and date the form?
- Step 4 – Did you mail your form or did you get the form receipted at the union hall during the nominating period?
- Step 5 – Did you check your form to make sure steps 1 – 4 are properly completed?
