Paragraph 109 of the UAW/GM Agreement (Leave of absence for Union Activity):

(109) Employees elected to a permanent office in or as a delegate to, any labor activity necessitating a leave of absence, shall be granted such leave for a minimum of first half or the second half of their shift and not to exceed one year and shall, at the end of the term in the first instance, or the end of the mission in the second instance, be guaranteed reemployment if there is sufficient work for which they are in line at the then current rate of pay. Written notice for such leaves, giving the length of leave, shall be given to the Local Plant Management as far in advance as possible but in no event later than 24 hours prior to the shift such leave is to become effective. Seniority will accumulate during the period of such leaves.

- **ACTION FOR 109s:** New to process you will need to bring 2 forms of ID such as driver licenses, Social Security Card, Birth Certificate and/or passport. This is for W-4, I-9, and voucher. This will need done before getting paid.





Blackout Days:

Please be aware that you cannot call off (unless excused in advance) **on the last scheduled workday prior to and the next scheduled workday after each specified holiday**. Failure to get approval prior to the blackout days will result in a Doc 8 occurrence and your holiday pay will be impacted. (Page 336/337 of the UAW/GM National Agreement)

Planning Vacation:

Per paragraph 202c of the UAW/GM National Agreement:

Vacation slips will be passed out in February. Employees may make application for vacation time off indicating their first, second and third choices. **IF A PLANT VACATION SHUTDOWN WEEK IS SCHEDULED, THE DATES OF SUCH SHUTDOWN WEEK ARE TO BE INCLUDED IN THE EMPLOYEE'S VACATION SCHEDULE.**

Seniority will be the basis for resolving priority in the event employees apply for time off than can be spared from the job at a given time.

No Call/No Shows:

The Company will use your VR hours (if applicable) to cover the absence **AND** issue a Doc 8 occurrence. (UAW/GM Agreement page 333-340)

FMLA(Family and Medical Leave Act):

Ultium Cells employees who became GM leased employees, when you call Sedgwick to file for FMLA, please make sure you tell the Sedgwick representative that you worked for Ultium Cells and are now a GM leased employee. The Sedgwick representative will transfer you over to a dedicated representative that will have your total hours worked under Ultium Cells and GM.
