### **LAYOFF INFORMATION**

Reminder: The upcoming layoff will require you to use a pin number on the unemployment site. If you have lost, forgotten or do not have a pin number, please call 1-877-644-6562 to get a pin or reset your pin in advance. Do not wait until you are laid off to call. Press 1 for English, then 4 to apply for a pin. You should receive instructions for filing unemployment from your supervisor. If not, you may pick up the instructions from labor, benefits or your committeeman.

### **FAILURE TO DO SO WILL RESULT IN LOSS OF BENEFITS**

You must open a new claim or reopen an existing claim at [www.unemployment.ohio.gov](http://www.unemployment.ohio.gov) or by calling 1-877-644-6562 by March 17, 2017. If you fail to open your claim by March 17, 2017, you will not have opened your claim in a timely manner and will result in loss of benefits. You must then log back into the unemployment website on March 19, 2017 and claim week ending March 18, 2017. Once your waiting week has been credited or you have been paid for the week you are claiming, and you have received your determination of benefits, then you can log into [www.layoffbenefits.com](http://www.layoffbenefits.com) to apply for sub.

Use your social security number to log into the sub site. If your monetary determination is not set up yet, you must do so before you apply for a weekly benefit. Once you have set up your monetary determination that you received from unemployment, you may then claim week ending March 19, 2017 from the drop box. Make certain you are claiming the correct week for which you are laid off.

The benefit reps are not permitted to file unemployment claims for our members, but can direct a member and answer questions.

Benefit reps will be available to assist you Monday thru Friday, in plant, from 7:00 am to 3:00 pm. A benefit rep can also assist our members at the union hall from 7:30 am to 3:00 pm. Please call 330-824-7011 or 330-824-7003 for in plant benefits or 330-538-2214 for a rep at the hall.
